ARTICLES OF INCORPORATION

MINNESOTA NATIONAL ORGANIZATION FOR WOMEN, INC. (~~NOW~~)

We, the undersigned, for the purpose of forming a corporation under and pursuant to the provisions of Chapter 317 Minnesota Statutes, known as the Minnesota Nonprofit Corporation Act, do hereby associate ourselves together as a body corporate and adopt the following Articles of Incorporation:

ARTICLE I.

The name of this corporation shall be: Minnesota National Organization for Women, Inc. (~~NOW~~).

ARTICLE II.

The purpose of this corporation shall be: to take action to bring women into full participation in the mainstream of American society now, exercising all the privileges and responsibilities thereof in truly equal partnership with men. This purpose includes, but is not limited to equal rights and responsibilities in all aspects of citizenship, public service, employment, education and family life, and it includes freedom from discrimination because of marital status or parenthood.

ARTICLE III.

This Corporation shall not afford pecuniary gain, incidentally or otherwise, to its members.

ARTICLE IV.

The period of duration of corporate existence of this corporation shall be: perpetuity.

ARTICLE V.

The location of the registered office of this corporation in this state is: 1434 Asbury Street, City of Saint Paul, County of Ramsey.

ARTICLE VI.

ARTICLE VII.

The number of directors constituting the first board of directors of this corporation shall be three, and the tenure in office of such first board of directors shall be one year or until successors are elected and qualified.
