

MISSION STATEMENT

Gender Justice is a nonprofit legal and policy advocacy organization dedicated to advancing gender equity through the law.

VISION STATEMENT

We envision a world where all people can thrive regardless of their gender, gender expression, and sexual orientation. This involves dismantling legal, structural, and cultural barriers that contribute to gender-based oppression and ensure people of all genders a right to bodily autonomy, safety, health, and opportunity.



Terms and Definitions

Gender Identity: The term "gender identity"—distinct from the term "sexual orientation"—refers to a person's **innate**, **deeply felt psychological identification** of gender, which may or may not correspond to the person's sex assigned at birth.

Gender Expression: Gender expression refers to external characteristics and behaviors that are socially defined as masculine or feminine, such as dress, grooming, mannerisms, speech patterns, and social interactions. Social or cultural norms can vary widely and some characteristics that may be accepted as masculine, feminine, or expansive/neutral in one culture may not be assessed similarly in another.

Terms and Definitions

Transgender: An umbrella term for people whose gender identity and/or gender expression differs from the sex they were assigned at birth.



Gender Non-Conforming, Genderqueer, Gender Expansive and Non-Binary:

Terms used to describe people whose gender expression and identity fall outside of the binary categories of masculinity/femininity and man/woman.

Terms and Definitions

<u>Cisgender</u>: A term used to describe people who are not transgender, because they identify with the gender they were assigned at birth. "Cis" is a Latin prefix meaning "on the same side as." It is used in chemistry and other sciences like Geography, for example: transAtlantic vs cisAtlantic

<u>Intersex</u>: Intersex is an umbrella term for people who are born with one or more traits in their chromosomes, genitals, hormones, or internal reproductive organs. Some intersex traits are identified at birth, while others may not be discovered until puberty or later in life.

Pronouns

Using pronouns respectfully avoids gender assumptions and fosters inclusivity. Share your pronouns, ask others for theirs, and embrace using they/them to create a welcoming, compassionate space.






Anti-Trans Laws

Why the attacks on trans rights?

How targeting trans people for discrimination advances White Christian Nationalism

White Christian Nationalism Seeks to Enforce a Narrow, Rigid View of Gender

- White Christian nationalism promotes a worldview where rigid, binary gender roles are seen as divinely mandated and non-negotiable.
- Trans people challenge this framework by asserting their right to bodily autonomy, making them a direct target for white Christian nationalist movements.

Attacks on Trans Rights Are Part of a Larger Authoritarian Agenda

- The same forces pushing anti-trans policies are also attacking reproductive rights, racial justice, and democracy itself.
- White Christian nationalism relies on state control over personal freedoms—dictating who can marry, who can parent, and who can exist safely in public spaces.

How targeting trans people for discrimination advances White Christian Nationalism

Anti-Trans Policies Are Rooted in Religious Extremism, Not Science

- White Christian nationalist rhetoric fuels policies that ignore medical consensus on gender-affirming care.
- These policies are not about protecting children or fairness; they are about enforcing religious dogma through law.

Racial and Gender Oppression Are Interconnected

- White Christian nationalism seeks to preserve a social hierarchy where white, cisgender men hold power.
- The same ideology that justifies attacks on trans people also fuels racist voter suppression, book bans, and attacks on reproductive freedom.

The real threat to women's sports? It's not trans athletes.


There are real problems facing women and girls sports

Our Laws in Minnesota

Legislative Protections:

- Minnesota Human Rights Act
- Minnesota Safe and Supportive Schools Act
- Ban on Conversion Therapy
- Trans Refugee State

Other Policy Protections:

Minnesota State High School League Policy Attorney General Keith Ellison

Court Wins:

Rumble Case (Section 1557 of the ACA) cover trans folks

Tovar Case – Health insurers cannot discriminate in the coverage that they provide

Lusk Case – Department of Corrections (DOC is going to give each inmate a consultant for their gender affirming care)

NH v. Anoka Hennepin – Schools cannot segregate trans students and schools have to permit student to use the bathroom and locker rooms that align with their gender identity

Cooper Case (USA Powerlifting cannot discriminate against trans athletes)

Proposed Minnesota ERA Ballot Language

Title: The Minnesota Equal Rights Amendment

Ballot Question:

Shall the Minnesota Constitution be amended to say that all persons shall be guaranteed equal rights under the laws of the state, and that the state shall not discriminate against any person on account of race, color, national origin, ancestry, disability, or sex, including pregnancy, pregnancy outcomes, reproductive freedom, gender identity, gender expression, and sexual orientation?

Proposed Minnesota ERA

All persons shall be guaranteed equal rights under the laws of this state. The state shall not discriminate against any person in intent or effect on account of one or more of the following:

- (a) Race;
- (b) Color;
- (c) National origin;
- (d) Ancestry;
- (e) Disability; or
- (f) Sex, including but not limited to:
 - (i) Pregnancy, pregnancy outcomes, and reproductive freedom
 - (ii) Gender identity or gender expression
 - (iii) Sexual orientation

Any action by the state that denies an individual's equal rights shall be invalid unless, at a minimum, it is the least restrictive means of achieving a compelling governmental interest.

The proposed MN ERA would require lawmakers to look past the question of facial classifications, and impacts of the laws they exacerbating, or mitigating disparities in the state of

Currently in MN discrimination based on religion and race, as well as abortion rights, are subject to strict scrutiny. Other states apply strict scrutiny to all forms of sex discrimination, disability discrimination, as well as color, national origin, and ancestry discrimination. We'd like to see that in MN. Pennsylvania's ERA, though a landmark achievement, lacked explicit reproductive freedom protections, requiring decades of legal battles to secure partial recognition. Through our research, and advice from colleagues in other states, like New York, it is critical to be explicit about reproductive freedom.

Freedom

Gender Identity & **Expression**

Explicitly including "gender expression" protects all individuals—transgender and cisgender—from discrimination based on non-conformity to gender norms. Since gender identity applies to everyone, explicit language ensures comprehensive protection for all gender identities against discrimination and sex stereotyping.

Why We Need the Minnesota ERA

The ERA would guarantee equal rights under Minnesota law for *everyone* – leaving no one out. Here are a few examples of how it will make a real difference:

- **Protects Reproductive Freedom:** Ensures that decisions about pregnancy and healthcare are protected from government interference.
- **Secures LGBTQ+ Rights**: Strengthens protections for transgender and nonbinary people, as well as LGBQ+ individuals, against discrimination.
- **Advances Disability Justice**: Guarantees that Minnesotans with disabilities receive equal protection under the law.
- **Combats Racial Discrimination**: Offers stronger legal recourse against state-sanctioned racial injustice and inequality.

In a time when basic rights and freedoms are under attack across the country, we fully support a state Equal Rights Amendment as a crucial step in protecting our rights and freedoms.
